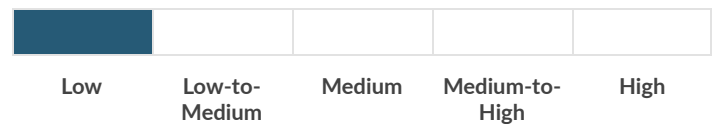

Risk Tolerance



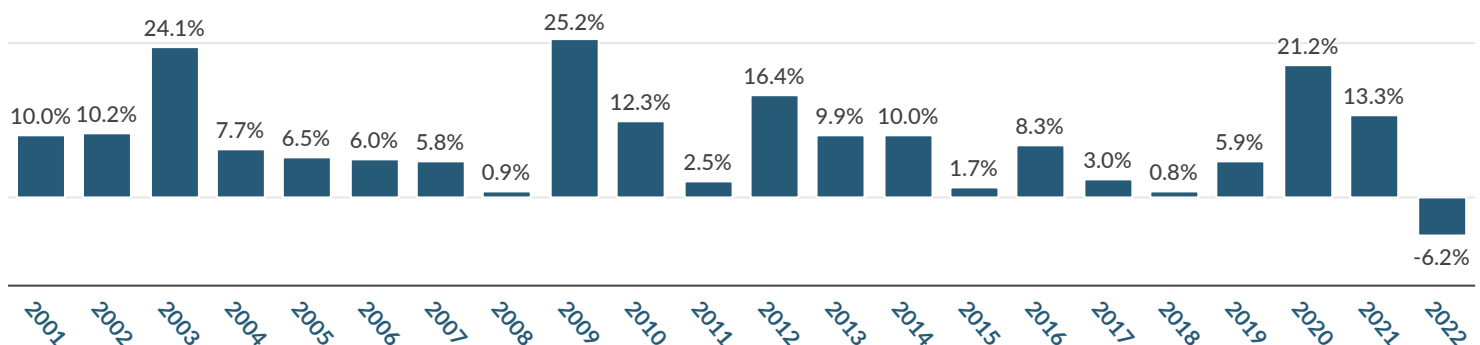

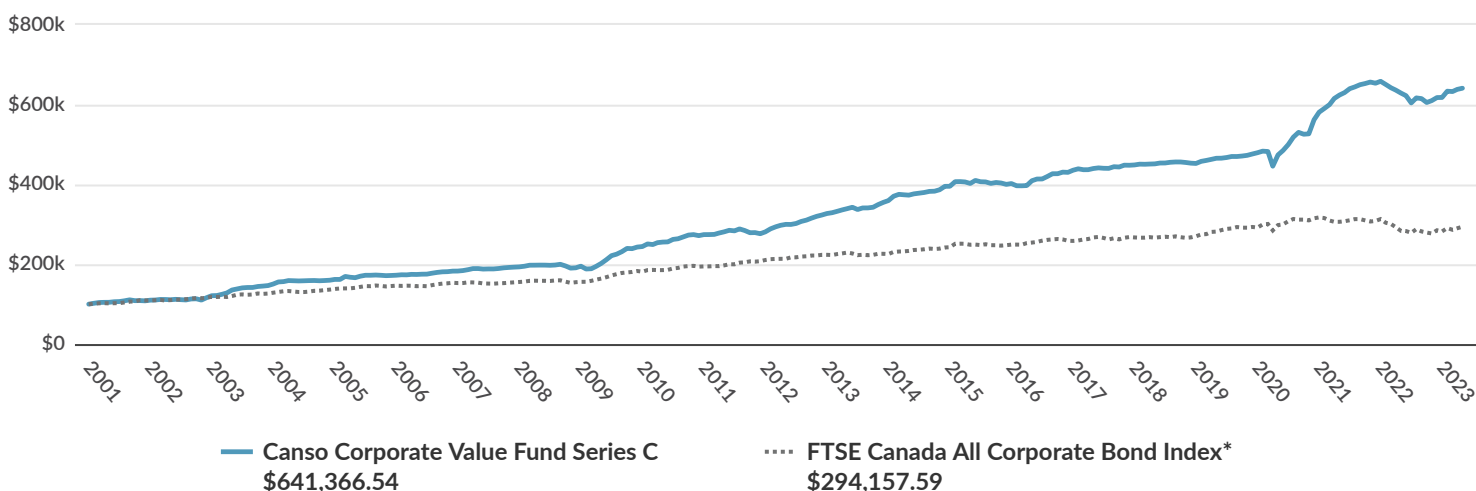
