

Lysander-Canso Short Term and Floating Rate Fund was awarded the 2022 Fundata FundGrade A+ Award in the Canadian Short Term Fixed Income Category, out of 162 funds. The FundGrade start date was 1/31/2014 and FundGrade end date was 12/31/2022. Performance for the fund (Series A) for the period ended December 31, 2023 was 6.5% (1 year), 1.0% (3 years), 2.3% (5 years) and 1.9% (since inception – Sep 18, 2013).
