

Lysander-Canso Corporate Value Bond Fund was awarded the 2024 Fundata FundGrade A+® Award in the Global Corporate Fixed Income Category, out of 29 funds. The FundGrade start date was 12/31/2014 and FundGrade end date was 12/31/2024. Performance for the fund (Series A) for the period ended April 30, 2025 was 5.7% (1 year), 4.0% (3 years), 7.9% (5 years) and 5.3% (10 years).

The annual FundGrade A+® Awards are presented by Fundata Canada Inc. to recognize the "best of the best" among Canadian investment funds.
