This Fund invests primarily in equity securities of Canadian corporate issuers.

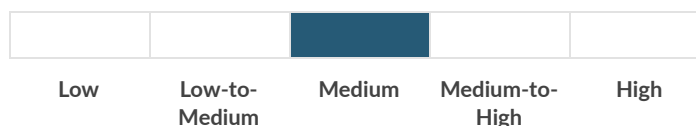
Why Invest in this Fund?
