

Lysander-Canso Corporate Value Bond Fund was awarded the 2024 Fundata FundGrade A+® Award in the Global Corporate Fixed Income Category, out of 29 funds. The FundGrade start date was 12/31/2014 and FundGrade end date was 12/31/2024. Performance for the fund (Series A) for the period ended September 30, 2025 was 4.8% (1 year), 6.4% (3 years), 6.4% (5 years) and 5.7% (10 years).

The annual FundGrade A+® Awards are presented by Fundata Canada Inc. to recognize the "best of the best" among Canadian investment funds. The FundGrade A+® calculation is supplemental to the monthly FundGrade ratings and is calculated at the end of each calendar year. The FundGrade rating system evaluates funds based on their risk-adjusted performance, measured by Sharpe Ratio, Sortino Ratio, and Information Ratio.
