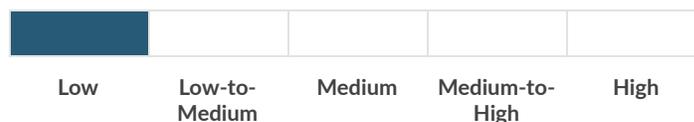
## Why Invest in this Fund?




