What does the fund invest in?

This Fund is a fixed income fund that invests primarily in a diversified portfolio of U.S. dollar denominated short term fixed income and floating rate debt securities. The Fund may purchase securities of foreign issuers.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

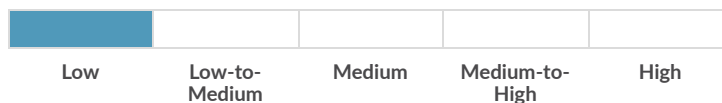
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Lysander Funds Limited has rated the volatility of this Fund as **Low**.

This rating is based on how much the Fund's returns have changed from year to year. It doesn't tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

Like most mutual funds, this Fund doesn't have any guarantees. You may not get back the amount of money you invest.

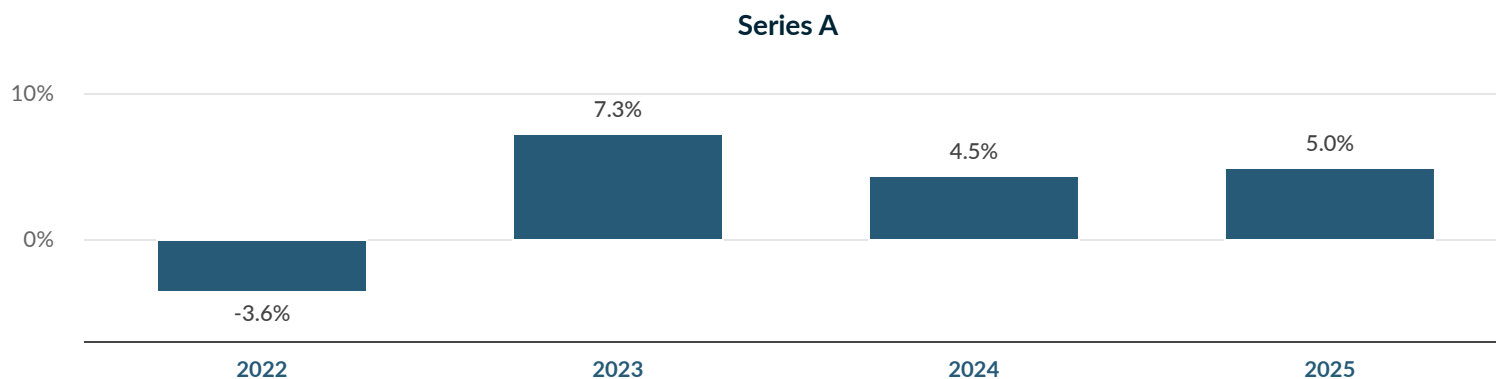
How has the fund performed?

This section tells you how Series A Units of the Fund have performed over the past 4 years. Returns are after fund expenses have been deducted. These expenses reduce the Series' returns.

On January 1, 2025, the management fee of this Series changed from 1.05% to 0.95%. This change could have affected the performance of the Fund had this change been in effect throughout the performance measurement period.

Year-by-year returns

This chart shows how Series A Units of the Fund performed in each of the last 4 years. The Series dropped in value in 1 of the 4 years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for this Series of the Fund in a 3-month period over the past 4 years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

The annual compounded return of Series A was 2.47% since its start date. If you had invested U.S. \$1,000 in the Series A Units of the Fund on its start date of May 12, 2021 your investment would have been worth U.S. \$1,128.92 on April 30, 2026.

Who is the fund for?

Investors who:

- plan to hold this investment for the medium term
- wish to invest in a fund that is primarily denominated in U.S. dollars
- want to primarily receive interest income and
- can handle the currency volatility associated with fixed income investments denominated in U.S. dollars.

A word about tax

In general, you'll have to pay income tax on your share of the Fund's earnings and on taxable capital gains you realize from redeeming your investment. How much you pay depends on the tax rates that apply to you, and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions of income and taxable capital gains are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A Units of the Fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

Sales charges

There is only one sales charge option when you buy Series A Units.

Initial Sales Charge Option	0% to 5% of the amount you buy	U.S. \$0 to U.S. \$50 on every U.S. \$1,000 you buy	You and your representative decide on the rate of commission that you pay when you buy Units. The initial sales charge is deducted from the amount paid at the time of purchase. It goes to your representative's firm as a commission.

Fund expenses

You do not pay these expenses directly. They affect you because they reduce the Fund's returns.

As at December 31, 2025, the expenses of the Series were 1.18% of its average value. This equates to U.S. \$11.80 for every U.S. \$1,000 invested.

More about the trailing commission

The trailing commission is an ongoing commission. Lysander Funds Limited pays your representative a trailing commission for as long as you own Units of this Series of the Fund. It is for the services and advice your representative and their firm provide to you. Lysander Funds Limited pays the trailing commission to your representative's firm. It is paid by Lysander Funds Limited out of the management fee and is based on the value of your investment. The maximum annual trailing commission rate for Series A Units of the Fund is 0.50%, which equals U.S. \$5.00 for every U.S. \$1,000 invested.

Other fees

You may have to pay other fees when you buy, hold, sell or switch Units of this Series of the Fund.

Fee	What you pay
Short-term Trading Fee	1% of the amount redeemed or switched if you redeem or switch within 7 days of purchase. This fee goes to the Fund.
Switch Fees	Your representative's firm may charge you up to 2% of the net asset value of the switched Units, as negotiated between you and your representative's firm.

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within 2 business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
